SECTION 4: First aid measures

4.1 Description of first aid measures

Place insured person out of danger zone to fresh air immediately. Ensure quiet, warmth, and provide resuscitation if necessary. If necessary contact medical advice. Take to a doctor, in a raised position if there are breathing difficulties.

4.1.1 After SKIN Contact

Remove contaminated clothing immediately. Rinse the affected skin or mucous membrane thoroughly for min. 15 minutes under running water. (If possible) use soap. Avoid neutralisation. Then apply a loose bandage.

In the event of respiratory distress ensure that the patient inhales oxygen. Secure the breathing, heart and circulatory function. ---

8.2 **Exposure controls**
